

COLLECTION OF PRIVATE ROAD CHARGE ON JALAN GENTING HIGHLANDS

Please be advised that Lingkaran Cekap Sdn Bhd (“**LCSB**”), the authorised road operator for Jalan Genting Highlands, will implement road charges in two phases.

Effective 28 May 2026

All permitted road users, other than exempted categories listed below, shall be required to pay the applicable road charge upon entry into Jalan Genting Highlands.

Payment will be collected at the following locations: -

1. Genting Highlands Entry at Genting Sempah
2. Gohtong Jaya Entry at the Gohtong Jaya roundabout

Class	Description	Genting Highlands Entry	Gohtong Jaya Entry
1	Car / Van	RM 5.00	RM 5.00
2	Medium Lorry*	RM 15.00	RM 15.00
3	Heavy Lorry*	RM 25.00	RM 25.00

5	Bus*	RM 5.00	RM 5.00

*Vehicles under Class 2, 3, 4 and 5 are required to enter via the “Lorong Khas” lanes or Licence Plate Recognition (“**LPR**”).

Categories of Exempted and Registered Vehicles

Certain categories of vehicles have been identified for exemption from road charges subject to registration with LCSB. These categories are determined based on essential operational needs and public service considerations:

1. Exempted (No Registration Required)
 - (a) Emergency Vehicles

(b) Motorcycles

2. Exempted (Registration Required and entry via LPR or Lorong Khas)

Private Vehicles of public servants whose place of work is at identified Government Institutions in Genting Highlands

- i. SK Sri Layang
- ii. SMK Sri Layang;
- iii. Institut Aminuddin Baki;
- iv. Balai Polis Genting Highlands;
- v. Balai Polis Gohtong Jaya;
- vi. Balai Bomba dan Penyelamat Genting Highlands;
- vii. Klinik Desa Sri Layang;
- viii. Pejabat Daerah Kecil Genting Highlands;
- ix. Pejabat Daerah dan Tanah Bentong;
- x. Pejabat Cawangan Majlis Perbandaran Bentong(Cawangan Genting Highlands)
- xi. Pejabat Setiausaha Kerajaan (SUK) Negeri Pahang (Cawangan Genting Highlands)

Effective 28 June 2026

3. LCSB will register up to two (2) Class 1 vehicles (“**Registered Vehicles**”) for eligible permanent residents of Genting Highlands who opt for either one of the following :

a) Preferential Rate per Entry (Registration Required)

Eligible permanent residents will enjoy a preferential rate of 10% lower than the normal rate per entry by using the LPR Lanes / Lorong Khas.

Registered Vehicles will not incur any charges prior to 28 June 2026.

b) Season Pass Scheme (Registration Required)

In addition, LCSB will introduce a six-month season pass scheme for registered permanent residents. The season pass will entitle holders to unlimited entries into Jalan Genting Highlands throughout its validity period via LPR Lanes or Lorong Khas, providing greater convenience and significant cost savings. Permanent residents who are interested can obtain the season pass by submitting an application and making the necessary payment.

Exemption and preferential rates will be reviewed periodically to ensure continued relevance and to reflect operational or policy changes.

Please note that all permitted road users are subject to the Rules and Regulations governing the usage of Jalan Genting Highlands, including the applicable terms and conditions for road charges. These documents, together with a set of Frequently Asked Questions, full details of vehicle categories, information on preferential rates, registration procedures, and the season pass scheme, are available at our official website www.lingkarancekap.com. Road users are encouraged to visit the website regularly for updates.
